EPT 120 SOCIOLOGY OF DISASTER

COURSE DESCRIPTION:

Prerequisites: None Corequisites: None

This course is designed to overview sociological disaster research, disaster system, and alternative research approaches. Topics include human and organizational behaviors, long term disaster impact on communities, disaster warning, and evacuation considerations. Upon completion, students should be able to assess and predict the impact of disaster-related human behavior. Course Hours Per Week: Class, 3. Semester Hours Credit, 3.

- 1. Describe the relevance of emergent systems for disaster managers.
