Paycheck stubs typically include:

- Company name, address, and phone number
- Your name and address and possibly your Social Security Number
- The pay period beginning and end date
- Earnings for the current period and Year-to-Date (YTD) in dollars, hours, and the hourly pay rate
- Taxes and benefits removed from the total for the current period and Year-to-Date (YTD), broken down by each type.
- Totals for Gross pay, Ded Taxable Gross, Total Taxes, Total Deductions, and Net Pay
